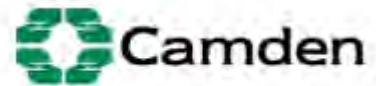

Environmental Information Regulations 2004

Thank you for your request for information, received on 17 August 2017. You provided further clarification by email received on

When the council had proposed the perimeter fencing on the Curnock Street Estate they were some Fire Safety reports stating that certain paths cannot be fenced because of fire safety reasons and because it was a public path.

Any fire safety reports regarding that project would be useful.

Finally I am looking for any documents related to that fencing project. Documents such as drawings, feedback/consultation results, health and safety reports, feasibility reports, affordability reports, budget reports, etc

You requested:

In 2001 the camden council had proposed a perimeter fence around the Curnock Street Estate. I would like to know the following:

- 1) Can I have the original plans?***
- 2) Can I have a copy of the documents showing that the path between Bayham Street and Camden Street was ok to be fenced?***
- 3) Fire safety reports.***
- 4) Any other document.***

Please find attached information concerning the proposed fencing of the estate. Please note this information has been redacted – please see the exception notice below.

There are no documents on file about the path between Bayham Street and Camden Street. There is no fire safety report on file concerning the fencing proposal - other Health & Safety files are part of the contract but these do not refer to the proposed fencing. Please note that the Council would not retain all original documents due passing of time.

Exception

The exception that applies is:

regulation 12(3) which states “*the information requested includes personal data of which the applicant is not the data subject, the personal data shall not be disclosed otherwise than in accordance with regulation 13.*”

regulation 13(1) states:

(1) To the extent that the information requested includes personal data of which the applicant is not the data subject and as respects which either the first or second condition below is satisfied, a public authority shall not disclose the personal data.

(2) The first condition is—

(a) in a case where the information falls within any of paragraphs (a) to (d) of the definition of “data” in section 1(1) of the Data Protection Act 1998, that the disclosure of the information to a member of the public otherwise than under these Regulations would contravene—

(i) any of the data protection principles;

Relatively junior Council Officers, workers from outside agencies and the other individuals would have no expectation that their personal information would be released into the public domain. The release of the information would be a breach of the Data Protection Act 1998 as outlined above and therefore regulation 13 does not permit release and the information has been withheld.

Notes

If you are unhappy with any aspect of the way in that your request has been processed then you have the right to issue a complaint. If you wish to issue a complaint, please set out in writing your grounds of appeal (within 2 months of this correspondence) and send it to: Information and Records Management, London Borough of Camden, Old Town Hall, Judd Street, London, WC1H 9JE and your complaint will be administered through our Internal Review procedure.

If you are still not satisfied following the Internal Review, you have a right to appeal to the Information Commissioner’s Office. They can be contacted at: Wycliffe House, Water Lane, Wilmslow, Cheshire. SK9 5AF.
